NARRATIVE: SHERIFF'S SPECIAL VICTIMS BUREAU DETECTIVES ARE INVESTIGATING THE RAPE AND  
KIDNAPING OF A 14 YEAR OLD FEMALE IN THE 500 BLOCK OF SOUTH ATLANTIC AVENUE, EAST LOS ANGELES,  
ON JANUARY 8, 2009.

DETECTIVES HAVE LEARNED THAT A 14 YEAR OLD FEMALE WAS WALKING HOME FROM SCHOOL  
WHEN SHE WAS CONFRONTED BY SALVADOR RAMOS, MH/23. RAMOS ENGAGED THE VICTIM IN CONVERSATION  
AND THEN FORCED HER TO WALK WITH HIM TO ATLANTIC PARK. ONCE AT THE PARK, HE SEXUALLY  
ASSAULTED THE VICTIM, RELEASED HER AND THEN FOLLOWED HER. AS SHE WALKED AWAY, RAMOS CAUGHT  
UP TO HER AND FORCED HER BACK TO THE PARK WHERE HE SEXUALLY ASSAULTED HER AGAIN.

DURING THE SUBSEQUENT INVESTIGATION, RAMOS WAS ARRESTED TODAY (01-09-2009), AND IS  
CURRENTLY BEING HELD AT EAST LOS ANGELES SHERIFF'S STATION IN LIEU OF \$300,000 BAIL.
