NARRATIVE: SHERIFF'S SPECIAL VICTIMS DETECTIVES ARRESTED AN EMPLOYEE OF A LENNOX MIDDLE  
SCHOOL ON FRIDAY, FEBRUARY 13, 2009, FOR LEWD OR LASCIVIOUS ACTS WITH A CHILD UNDER THE AGE OF 14.

THE SUSPECT BERNARD LOBJOIS, MW/57, A CUSTODIAN AT MOFFETT ELEMENTARY SCHOOL, 11050  
LARCH AVENUE, LENNOX, FONDLED TWO FEMALE STUDENTS IN TWO SEPARATE INCIDENTS.

THE MOST RECENT INCIDENT OCCURRED ON FEBRUARY 10, 2009, WHEN THE 8-YEAR-OLD VICTIM  
WAS CONFRONTED BY THE SUSPECT WHEN SHE ENTERED THE GIRLS' BATHROOM. AT THAT TIME LOBJOIS  
FONDLED THE VICTIM'S CHEST AND PRIVATE AREA OVER HER CLOTHING. WHEN THE GIRL TRIED TO GET AWAY  
FROM LOBJOIS HE STRUCK HER IN THE FACE AND THREATENED TO HARM HER FAMILY IF SHE TOLD ANYONE  
ABOUT THE INCIDENT.

THE FIRST INCIDENT OCCURRED, ALSO IN THE GIRL' BATHROOM, ON DECEMBER 10, 2008. DURING  
THIS INCIDENT THE FIRST VICTIM AND A 7-YEAR-OLD FRIEND WERE ACCOSTED BY LOBJOIS AND HE FONDLED  
BOTH GIRLS OVER AND UNDER THEIR CLOTHING. LOBJOIS AGAIN THREATENED TO HARM THE VICTIMS IF THEY  
REPORTED HIM. THE SUSPECT ALSO SLAPPED THE 8-YEAR-OLD VICTIM IN THE FACE.

AFTER THE INCIDENT ON FEBRUARY 10, 2009, THE VICTIM TOLD HER MOTHER WHAT HAPPENED AFTER HER MOTHER SAW A MARK ON HER DAUGHTER'S FACE WHERE THE SUSPECT HIT HER. AT THAT TIME THE 8-YEAR OLD VICTIM ALSO RELATED THE DECEMBER 10, 2008, INCIDENT INVOLVING HER 7-YEAR-OLD FRIEND.

SPECIAL VICTIMS DETECTIVES ARRESTED SUSPECT LOBJOIS ON FEBRUARY 13, 2009. HE WAS BOOKED AT LENNOX STATION FOR LEWD/LACIVIOUS ACTS WITH A CHILD UNDER 14 YEARS OF AGE, CRUELTY TO A CHILD, AND CRIMINAL THREATS. LOBJOIS WAS RELEASED ON 100, 000 BOND ON FEBRUARY 14, 2009.
