NARRATIVE: SHERIFF'S HOMICIDE DETECTIVES ARE INVESTIGATING A SHOOTING THAT OCCURRED IN THE 3600 BLOCK OF ROSEMEAD BOULEVARD, ROSEMEAD, THE SHOOTING LEFT TWO MALE HISPANIC MEN DEAD, AND THREE OTHER MALE HISPANIC MEN WOUNDED.

THE TWO MURDER VICTIMS WERE PRONOUNCED DEAD AND ARE STILL AT THE SCENE.

THE THREE OTHER GUNSHOT WOUND VICTIMS WERE TRANSPORTED TO LOCAL HOSPITALS. THEY ARE LISTED IN VARIOUS CONDITIONS.

TEMPLE STATION DEPUTIES RESPONDED TO THE SCENE REGARDING A POSSIBLE SHOTS FIRED CALL. WHEN THEY ARRIVED THEY FOUND THE FIVE VICTIMS AND CALLED FOR FIRE/PARAMEDICS. DEPUTIES DETERMINED THAT THE SHOOTING OCCURRED DURING THE COURSE OF A LARGE PARTY. THE TWO SUSPECTS ENTERED THE PARTY AND BEGAN SHOOTING FOR UNDETERMINED REASONS, THEN FLED ON FOOT IN AN UNKNOWN DIRECTION.

THERE IS NO FURTHER INFORMATION AT THIS TIME.
