SHERIFF'S HOMICIDE DETECTIVES ARE CONTINUING THEIR INVESTIGATION INTO THE CIRCUMSTANCES SURROUNDING AN OFFICER INVOLVED SHOOTING THAT OCCURRED IN THE 8000 BLOCK OF SEVILLE AVENUE, SOUTH GATE.

SHERIFF'S HOMICIDE DETECTIVES LEARNED THAT BELL POLICE OFFICERS CONDUCTED A TRAFFIC STOP ON A WHITE VEHICLE WHICH WAS OCCUPIED BY TWO MALE ADULTS. WHEN THE VEHICLE STOPPED AND AS THE OFFICER EXITED HIS VEHICLE, ONE OF THE SUSPECTS FIRED SEVERAL ROUNDS AT THE OFFICER. THE SUSPECTS THEN DROVE AWAY AND A FOUR MILE PURSUIT ENSUED.

THE PURSUIT ENDED WHEN THE SUSPECTS VEHICLE CRASHED INTO A CONCRETE WALL AT THE INTERSECTION OF SEVILLE AVENUE AND SANTA ANA STREET, SOUTH GATE. AFTER THE CRASH, BOTH SUSPECTS EXITED THE VEHICLE AND ONE OF THE SUSPECTS IMMEDIATELY BEGAN FIRING AT BELL POLICE OFFICERS. THE SUSPECT'S ROUNDS STRUCK THE HOOD OF A BELL POLICE OFFICER'S VEHICLE.

AT THIS TIME, A BELL POLICE SERGEANT FIRED SEVERAL ROUNDS AT THE SUSPECT WHO WAS SHOOTING AT THE BELL POLICE OFFICER. THE SUSPECT THEN BEGAN RUNNING SOUTHBOUND ON COMMERCIAL PLACE FROM SANTA ANA STREET TO THE 8100 BLOCK OF COMMERCIAL PLACE. THERE, THE SUSPECT WAS MET BY A BELL POLICE SERGEANT AND A SECOND OFFICER-INVOLVED SHOOTING OCCURRED.

AN ASSISTING MAYWOOD OFFICER ARRIVED AT THE SCENE AND BOTH OFFICERS ENGAGED THE SUSPECT. THE SUSPECT, WHO WAS STRUCK SEVERAL TIMES IN THE UPPER TORSO, FELL TO THE GROUND. LOS ANGELES COUNTY PARAMEDICS RESPONDED AND PRONOUNCED THE SUSPECT DEAD AT THE SCENE.

THE SECOND SUSPECT WAS NOT LOCATED.

A WEAPON WAS RECOVERED AT THE SCENE.
