NARRATIVE: SHERIFF'S AIR-RESCUE 5 RESPONDED TO MOUNT HARVARD IN THE ANGELES NATIONAL FOREST THURSDAY (02/04/2010) MORNING AT APPROXIMATELY 10:00 A.M. AFTER THEY RECEIVED A CALL OF A FALL VICTIM AT THE LOCATION. THE 45-YEAR-OLD VICTIM WAS LOCATED 80 FEET OVER THE SIDE OF A CLIFF. SHERIFF'S PARAMEDICS PUT THE VICTIM IN A LITTER AND HOISTED HIM ONTO THE RESCUE HELICOPTER. HE WAS THEN TRANSPORTED TO A LOCAL HOSPITAL FOR ADDITIONAL TREATMENT OF POSSIBLE BROKEN RIBS.
