DETECTIVES HAVE LEARNED THAT MRS. MCKINESS WAS LAST SEEN WHEN SHE LEFT HER RESIDENCE TO RUN AN ERRAND DURING THE MORNING HOURS OF TUESDAY, FEBRUARY 23, 2010. ON WEDNESDAY, FEBRUARY 25, 2010, THE FAMILY MEMBERS REPORTED HER MISSING TO MAYWOOD POLICE DEPARTMENT PERSONNEL.

ON SATURDAY, FEBRUARY 27, 2010, MRS. MCKINESS' VEHICLE, A 2002 BLACK CHEVY TAHOE WAS FOUND ABANDONED IN THE HUNTINGTON PARK AREA.

MRS. MCKINESS IS DESCRIBED AS A FEMALE HISPANIC, 5'05" TALL, 180 POUNDS, BLACK HAIR AND BROWN EYES. SHE WAS LAST SEEN WEARING A GREY TOP, BLACK PANTS AND BROWN BOOTS.
