NARRATIVE: SHERIFF'S HOMICIDE DETECTIVES ARE EN ROUTE TO THE 6300 BLOCK OF BEAR AVENUE, BELL, TO INVESTIGATE THE CIRCUMSTANCES SURROUNDING A DEPUTY-INVOLVED SHOOTING.

NO DEPUTIES WERE INJURED.

THE SUSPECT WAS TRANSPORTED TO A LOCAL HOSPITAL FOR MEDICAL TREATMENT.

WHENEVER A DEPUTY-INVOLVED SHOOTING OCCURS INVOLVING LOS ANGELES COUNTY SHERIFF'S DEPUTIES, AND IT RESULTS IN THE WOUNDING OF A SUSPECT, MULTIPLE INDEPENDENT INVESTIGATIONS IMMEDIATELY BEGIN AT THE SCENE. THIS INCLUDES A SEPARATE INVESTIGATION BY THE OFFICE OF THE LOS ANGELES COUNTY DISTRICT ATTORNEY, AS WELL AS INVESTIGATIONS BY THE SHERIFF'S HOMICIDE BUREAU AND INTERNAL AFFAIRS BUREAU. ATTORNEYS WITH THE LOS ANGELES OFFICE OF INDEPENDENT REVIEW ALSO RESPOND TO THE SCENE, AND HAVE FULL ACCESS TO THE FACTS KNOWN TO THE SHERIFF'S DEPARTMENT THROUGHOUT EVERY PHASE OF THESE THOROUGH INVESTIGATIONS. ONCE CONCLUDED, EVERY ASPECT OF THE SHOOTING IS REVIEWED BY THE SHERIFF'S EXECUTIVE FORCE REVIEW COMMITTEE.
