NARRATIVE: SHERIFF'S HOMICIDE DETECTIVES RESPONDED TO THE 1200 BLOCK OF WEST 106TH STREET, LOS ANGELES, TO INVESTIGATE THE CIRCUMSTANCES SURROUNDING THE SHOOTING DEATH OF A MALE BLACK/25 WHICH OCCURRED ON WEDNESDAY, MARCH 17, 2010, AT 1:25 P.M.

DETECTIVES HAVE LEARNED THAT THE VICTIM WAS PLAYING BASKETBALL AT THE LOCATION WITH FRIENDS WHEN A BLACK VAN APPROACHED WITH THREE MALE BLACK OCCUPANTS. ONE OF THE OCCUPANTS FIRED MULTIPLE SHOTS AT THE VICTIMS, ONE OF WHICH STRUCK A VICTIM IN THE LOWER TORSO.

THE VICTIM WAS TRANSPORTED TO A LOCAL HOSPITAL WHERE HE SUCCUMBED TO HIS INJURIES ON THURSDAY NIGHT, MARCH 18, 2010.

THE MOTIVE FOR THE SHOOTING IS UNKNOWN.
